THOUGH THE COVID-19 PANDEMIC FORCED THE MUSEUM TO CLOSE ITS DOORS TO THE GENERAL PUBLIC IN THE SPRING OF 2020, THE FHM CONTINUED TO OFFER ITS QUALITY EDUCATIONAL RESOURCES ONLINE AND WAS ABLE TO IMPACT MORE THAN 115,000 PEOPLE DURING FY 2019-20.
